GIFTS THAT TRANSFORM

On December 19, 2000, Museum Director Anne d'Harnoncourt announced a major initiative in celebration of the Philadelphia Museum of Art's 125TH Anniversary in 2001. "Gifts That Transform" is an enterprise that seeks to acquire collection-transforming works of art—individual objects and entire collections—in all the Museum's fields of interest. Identified among the most pressing priorities was the need to strengthen the institution's holdings of works by African American artists. The goal is not simply to increase the number of objects, but to add masterpieces by major artists, thus making the Museum a destination for anyone with a serious interest in the field. Our chief challenge is to secure adequate funds for all curatorial departments to purchase such works. To accomplish the objectives set by the African American Collections Committee, the Museum has launched The Henry Ossawa Tanner Fund with the goal of raising \$5 million: \$2 million in immediate, spendable funds, of which \$500,000 is required for works of art already identified as being highly desirable (see "New

Acquisitions" insert) and a \$3 million acquisition endowment to ensure that the Museum can continue to expand its holdings in African American are well into the future. Income from this fund will enable curators to take advantage of opportunities when singular objects come up for auction. As an important component of this effort, gifts of major works of art from private collectors are also being sought.

The Philadelphia Museum of Art has a long tradition of acquiring works of art by African Americans. In 1899, the Museum used its earliest acquisition fund, established by the bequest of Mrs. W. P. Wilstach, to become the first encyclopedic American museum to purchase a painting by the city's native son, Henry Ossawa Tanner. The opportunity arose when Tanner's masterpiece, *The Annunciation*, made a triumphal American tour after being shown to great acclaim the year before at the Paris Salon.

Since that time, the Museum has welcomed works of art in all styles and mediums. The collections now contain hundreds of costumes, decorative arts, drawings, installations, textiles, multimedia works, paintings, photographs, prints, and sculpture by more than eighty African American artists. In addition to internationally acclaimed, academically trained artists such as Tanner, the Museum is dedicated to collecting objects by early craftsmen in all mediums and works by self-taught and visionary artists—such as Horace Pippin or Thornton Dial—who have often worked in obscurity for self-fulfillment alone.

There are still many great artists absent from the collections, or not represented sufficiently. Enclosed is a preliminary "Wish List" of artists whose work is being sought, as well as an illustrated list of works that the institution has already committed to acquiring. In addition to assembling a world-class collection of African American art, the Museum is dedicated to sharing and interpreting the objects with as large an audience as possible through research, educational programs, library resources, scholarly symposia, and the like. The master plan also provides for significant additional gallery space in which to exhibit the collections.

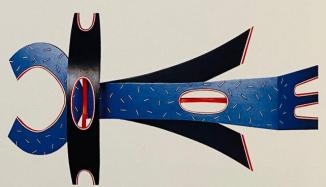

Ways to Give

As you can see, the Museum's collection thus far is the result of the combined generosity of many donors of funds or works of art over more than a century. We now invite you to join us as we strive to make our African American collection among the finest of any American art museum.

There are a number of ways in which you can join the Museum's distinguished family of financial supporters while enjoying substantial tax benefits.

GIFTS TO THE HENRY OSSAWA TANNER FUND

- Gifts of Cash. For federal income tax purposes, you may deduct the full amount of your cash contribution up to 50% of your adjusted gross income in the year of the donation. You may carry forward for up to five years after the year of the donation if necessary.
- Gifts of Marketable Securities. A gift of stocks, bonds, or mutual funds held for more than one year is frequently the most prudent and economical way to give. Transferring such assets to the Museum may provide you even greater tax savings than you would receive with an equivalent gift of cash. You can take this deduction for up to 30% of your adjusted gross income in the year of donation. Additionally, you may enjoy this tax deduction while paying no capital gains on appreciated value. You may also carry the deduction forward for up to five years after the year of the donation if necessary.
- Gifts of Closely Held Stock. The Museum accepts gifts of stock in closely held corporations (those in which no more than five individuals own more than half the stock's value). Such stocks may be given outright, given through a bequest, or used to establish a charitable remainder or lead trust.
- ◆ Matching Gifts. If your employer has a matching gifts program, your gift to the Museum could be doubled or even tripled. For additional information, contact the Museum for a list of participating companies or ask your employer's human resources department.

Planned Gifts. A planned gift may enable you to make a substantial gift while providing a secure lifetime income for yourself and/or a loved one. You can convert low- or non-income-yielding securities into a higher income stream while also qualifying for a substantial charitable tax deduction. Individuals may choose from a variety of planned gifts, all of which can be specially tailored to meet their specific financial goals. Some planned gifts include: charitable gift annuities, charitable remainder trusts, gifts of real estate and tax-deferred retirement plans, among many others.
